	CARSON	310-952-1766	\$100 - \$150+	On-site inspection required. Six month expiration. Buyer must acknowledge.
	COMPTON	310-605-5509	\$60 + \$60/ UNIT ADD'L	Inspection required. Residential only. Call for application form. Buyer acknowledgment of residential Building Report needed.
	CULVER CITY	310-253-5800	\$96 - \$128	No inspection required. Need Report on residential and commercial properties, not vacant land. Call for application. Takes ten business days. Buyer to acknowledge. Real estate agents=payment requirements.
